A traumainformed approach acknowledges the negative effects that trauma has on people's lives and aims to prevent retraumatization. GRANTS SPOTLIGHT BY JOAN BRODY: FORMING A 2025 GRANTS WORKING GROUP

Dear Grant Seekers,

It is almost grant season 2025! The US Department of Justice Program Plan and some fiscal year 2025 grant solicitations are projected to be released in the next month or so. It is an ideal time to reconvene or form a new internal grants working group in your agency. Every year, public safety agencies anticipate grant funding opportunities in the following subject areas. Other categories may also be available, but this is a good list to kick things off. Please note that some subject matter experts (SMEs) cover multiple areas.

- 1. Technology
- 2. Domestic Violence/Elder Abuse
- 3. Youth
- 4. Behavioral/Mental Health
- 5. Training
- 6. Patrol

- 7. Homeland Security
- 8. Research and Evaluation
- 9. Community Engagement
- 10. Crime Analysis
- 11. Crime Lab
- 12. Cyber Crime/Financial Crime

I recommend that you identify a working group lead or coordinator who can help convene your internal grants working group or committee. They can invite SMEs, schedule meetings, and help write a FY 2025 grant strategy or wish list.



GRANTS SPOTLIGHT, CONTINUED

You will want the SMEs assigned to each subject area to be midlevel personnel. If working group members are too high on the organizational chart, they won't have time to attend meetings or work on grant approaches. Ideally, you want someone who is working with, and in, the community but high enough in rank to have experience and knowledge about command staff priorities.

Finally, during or soon after you hold your first grants meeting, invite the chief or agency head to stop by to discuss their priorities and thank everyone for their time and participation. Even just a five-minute drop in will inspire your grants team and show them how important their work is to your agency.
